In addition, we would attend the specifics as advised. Some of the instances are stated herein. In page 3 and 5, the grammatical mistakes shall be attended. WTP stands for Willingness to pay. It was mentioned in parenthesis when the term "Willingness to pay"

in Page 3, Line 12 was first mentioned. The word "etc." in the draft shall be revised. The word "the" shall be used when referring to a specific institution or department. A past tense shall be used in line 2, page 6. The water quality testing section shall be rewritten as advised. The use of "make", "model" and "precision" shall be avoided. The correction of Table 3 instead of Table 1 shall be made in line 17/18 in page 8. CCME stands for Canadian Council of Ministers of the Environment that shall be stated in the draft.
